# Crack O' Dawn 5K *Run / Walk & Pancake Breakfast*

**Saturday, June 28, 2008 Location:** Boalsburg, PA.

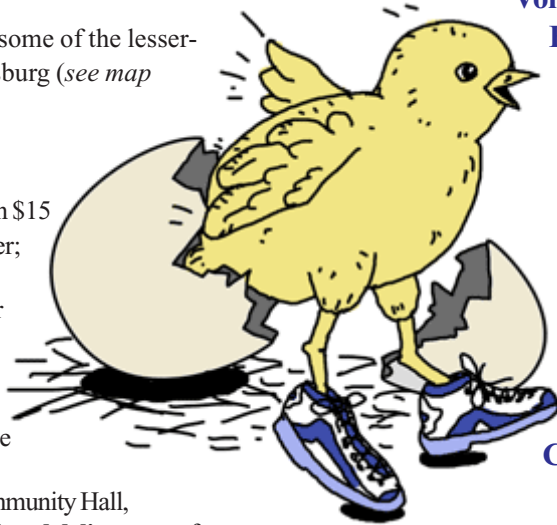
**Course:** An early morning tour of some of the lesser-known streets in the Village of Boalsburg (*see map on back*).

**Start Time:** 8:00 a.m.

**Registration:** Advance registration \$15 if postmarked by June 18, \$20 thereafter; \$8 for kids 11 & under. Fee includes pancake breakfast after the race (\$5 for non-participants) and a color race tee shirt. Race shirts guaranteed to all advance registered runners and walkers, and while supplies last on race day. Race day registration and packet pickup 7:00 a.m.-7:45 a.m. at Lions Community Hall, 130 Academy St., Boalsburg. **Send or hand deliver** entry form with fee (make checks payable to "VanDance") to Crack O' Dawn 5K, 103 E. Hamilton Ave., State College, PA 16801.

**Awards:** Door prize drawings, plus awards to top two male and female run finishers in each age group: 11& under, 12-14, 15-19, 20-29, 30-39, 40-49, 50-59, 60-69, 70-79, 80 & up.

**Directions:** *From State College:* Take Atherton Street (322 Business) south to Boalsburg. Turn right at the light at Church Street and either (A) turn at the first gravel drive on your left (watch for sign) into the gravel parking lot. After parking, walk up Academy Street, across Pine and continue to 130 Academy Street; or (B) follow Church Street to stop sign at Main Street. Turn left, and follow to Academy Street. Go left on Academy about 1 block to the gravel parking lot behind the fire station. Then walk up Academy to #130. *From Lewistown:* Take 322 East to Boalsburg exit, proceed to first traffic signal, turn left (Church Street) and follow directions above. *From Altoona:* Take I-99 to 220 N. to 322 E. to 45 exit "Old Fort," turn left onto 322 Business and follow directions above.
